First

“FEM BANDA Festival Internacional de Bandes de Música (International Wind Music Bands, Marching Bands and Fanfare Orchestras in Lleida) will take place from 2nd, 3rd, 4th and 5th July 2026.

The Organising Committee regulates, manages and coordinates the Festival.

Second

Application will take place starting **November 1st 2025 until 1st January 2026.**

The contest is open to national and international fanfares, wind and marching bands, as well as bands from music schools.

- Proposal for a 60-minute music program.

Fifth

Bands enrolled in Module A or Module B will carry out the following activities:

- Two Concerts in neighbouring village of the city of Lleida of sixty minutes of repertoire each..
- A marching entry and a fifteen-minutes (maximum allowed time) concert. Also, a joint performance with the rest of the participating ensembles, of a score by a local composer.
- A parade in the commercial street of Lleida.

Bands enrolled in Module C will carry out the following activities:

- One Concert in neighbouring village of the city of Lleida of sixty minutes of repertoire each..
- A marching entry and a fifteen-minutes (maximum allowed time) concert. Also, a joint performance with the rest of the participating ensembles, of a score by a local composer.

Sixth

The Municipal Band of Lleida, as the organizing entity of the International Music Bands Festival of Lleida, is interested in carrying out sociocultural exchanges with music bands from around the world, and has done so for nearly thirty years while leading the Fem Banda.

Any musical entity interested in carrying out an exchange between both entities can contact the organization, and we will begin developing proposals to make this project a reality.

Seventh

The following accommodation modules are available to participating bands:

Module A	Hotel accommodation and full board. All meals included from first day dinner to last day lunch.	3 nights	€ 235 /person
Module B	Hotel accommodation and full board. All meals included from first day dinner to last day lunch.	2 nights	€ 170 /person
Module C	Hotel accommodation and full board. All meals included from first day dinner to last day lunch.	1 night	€ 90 /person
<i>If you want half board, the prices will have a discount of €12 per person per day.</i>			

Tourist taxes are not included in the participation fee. Each participating band will be responsible for this tax and will pay it upon arrival at the hotel reception.

Groups that register for Modules A and B must arrive in Lleida on July 3rd before 7:00 PM.

Groups that register for Modules A and B must be in Lleida on July 3rd, 4th, and 5th.

Groups must vacate their rooms by 11:00 AM (throughout the morning) on the day of departure. Groups wishing to extend/anticipate their stay in Lleida can contact us for advice and to coordinate their stay and tourist excursions, if they deem it appropriate.

The remaining of the accommodation fee must be satisfied prior to **June 1st**. Further modifications after that date may incur in additional costs, which will be determined by the accommodation providers.

Eighth

The Evaluation Committee will meet to evaluate and select the participating bands.

Ninth

The Organizing Committee will evaluate the musical program attached to the registration application. We recommend that this program be varied, attractive, popular, and include at least one traditional music piece from the country, region, or autonomous community of the entity registering.

It is important to note that the audience is predominantly family-oriented, and the concerts are held outdoors without sound amplification

Tenth

Before **June 1st**, each participating band must send a list of musicians and artists, as well as the chaperones or others, participating in the festival.,

The name of the musicians/artists/chaperones and others will be informed surname first, name later, in alphabetical order. In the list, there must be the name and surname.

Eleventh

The participating bands will perform their acts in the official uniform of their institution. The organizing committee, together with the board of directors of the entities, will ensure the neatness of the band members during official events.

Twelfth

Bands not opting for any plans specified on the seventh clause, can use the Festival canteen. The prices of the canteen are as follows:

- Musicians / Chaperones, relatives, etc. – 1 ticket (1 meal) €17

Thirteenth

The Organising Committee will take any action to ensure the Contest takes place according to regulations. In the event any performance has to be postponed or stopped because of a justified reason, the Committee will decide on a later performance..

Fourteenth

Organising Committee is not responsible for any legal issue derived from the use of scores selected by participating bands.

Fifteenth

The dates of the festival are the ones enclosed in regulation number 1.

Sixteenth

Not submitting all the required documents or failing to do so before the set date would mean declining to participate in the Festival.

Seventeenth

When taking part in the festival, participating bands yield their image and sound rights, as well as all documents enclosed in the application, to the Organising Committee.

Eighyteenth

Any decision taken by the Organising Committee is final.

Nineteenth

Applications will be submitted using the enclosed model. All bank transfers must be in EURO. Any fee derived from bank transferring must be assumed by participating bands.

Twentieth

All participating bands will sign a document detailing all aspects of their participation in “*FEM BANDA Festival Internacional de Bandes de Música de Lleida*”.

All bands, and their organisations are submitted to the decisions of the courts in the city of Lleida, as stated in article 55 in Spanish Law of Civil Justice (Ley de Enjuiciamiento Civil), regarding any conflict of interests that these regulations might cause in “*FEM BANDA Festival Internacional de Bandes de Música de Lleida*”.
